**Approving or rejecting applications of prospective Contributing
Partners supporting proposals under topics HORIZON-JU-GH-EDCTP3-
2025-01-TB-01-two-stage, HORIZON-JU-GH-EDCTP3-2025-01-MALARIA-
02-two-stage, HORIZON-JU-GH-EDCTP3-2025-02-FELLOWSHIP-01-two-
stage and HORIZON-JU-GH-EDCTP3-2025-03-NETWORKS-01-two-stage**

THE GOVERNING BOARD OF THE GLOBAL HEALTH EDCTP3 JOINT UNDERTAKING (hereafter
“Global Health EDCTP3 JU”),

Having regard to Council Regulation (EU) No 2021/2085 of 19 November 2021 establishing the Joint
Undertakings under Horizon Europe (hereafter “the Founding Regulation”), in particular Articles 2(7),
9, 11(5), 17(2)(c) and 102(b) thereof,

Having regard to topics HORIZON-JU-GH-EDCTP3-2025-01-TB-01-two-stage, HORIZON-JU-GH-
EDCTP3-2025-01-MALARIA-02-two-stage, HORIZON-JU-GH-EDCTP3-2025-02-FELLOWSHIP-01-
two-stage and HORIZON-JU-GH-EDCTP3-2025-03-NETWORKS-01-two-stage and their specific
conditions, as spelt out in Global Health EDCTP3 JU’s 2025 work programme.

Having regard to the ranking list approved by Governing Board Decision GB/30/2025.

WHEREAS:

- (1) Letters of endorsement were submitted by prospective Contributing Partners to support
proposals under topics HORIZON-JU-GH-EDCTP3-2025-01-TB-01-two-stage, HORIZON-JU-
GH-EDCTP3-2025-01-MALARIA-02-two-stage, HORIZON-JU-GH-EDCTP3-2025-02-
FELLOWSHIP-01-two-stage, HORIZON-JU-GH-EDCTP3-2025-03-NETWORKS-01-two-stage,
and HORIZON-JU-GH-EDCTP3-2025-04-two-stage.
- (2) Applications should be approved if they are submitted by organisations that are eligible to
become Contributing Partners by way of a signed letter of endorsement that complies with the
requirements of Article 9 of the Founding Regulation and if they are related to proposals
selected for funding, including proposals placed on the reserve list.
- (3) Applications should be rejected if these conditions are not fulfilled.
