

GOVERNING BOARD OF THE GLOBAL HEALTH EDCTP3 JOINT UNDERTAKING DECISION N° GB/33/2024

Approving the actions selected for funding from the HORIZON-JU-GH-EDCTP3-2024-01-two-stage and HORIZON-JU-GH-EDCTP3-2024-02-01 two-stage calls for proposals

THE GOVERNING BOARD OF THE GLOBAL HEALTH EDCTP3 JOINT UNDERTAKING (hereafter "Global Health EDCTP3 JU"),

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EU) No 2021/2085 of 19 November 2021 establishing the Joint Undertakings under Horizon Europe and repealing Regulations (EC) No 219/2007, (EU) No 557/2014, (EU) No 558/2014, (EU) No 559/2014, (EU) No 560/2014, (EU) No 561/2014 and (EU) No 642/2014 (hereafter "the Founding Regulation"), in particular Articles 17(2)(u) and 19 (4) (j) thereof,

WHEREAS:

- (1) The Governing Board has approved the Annual Work Programme 2024 of the Global Health EDCTP3 JU including the topics for the call for proposals HORIZON-JU-GH-EDCTP3-2024-01-two-stage and HORIZON-JU-GH-EDCTP3-2024-02-01 two-stage with Decision GB/42/2023.
- (2) The calls for proposals HORIZON-JU-GH-EDCTP3-2024-01-two-stage and HORIZON-JU-GH-EDCTP3-2024-02-two-stage were published on the Funding & Tenders opportunities portal of the European Commission on 17 January 2024. The calls opened for submission of proposals on 18 January 2024 and the first stage closed on 4 April 2024. The second stage opened on 23 July 2024 with a deadline of 1 October 2024.
- (3) The evaluation using independent experts according to the Horizon Europe process as defined in the eGrants Vademecum was concluded on 08 November 2024. Ranking and as relevant reserve lists are proposed for the six topics under the HORIZON-JU-GH-EDCTP3-2024-01-two-stage call for proposals and the one topic under the HORIZON-JU-GH-EDCTP3-2024-02-01 two-stage call for proposals.

HAS ADOPTED THIS DECISION:

Article 1

The results of the evaluation and the actions selected for funding for the six topics under the HORIZON-JU-GH-EDCTP3-2024-01-two-stage call for proposals and the one topic under the HORIZON-JU-GH-EDCTP3-2024-02-01 two-stage call for proposals as shown in the table in Annex are hereby approved.
