

**GOVERNING BOARD OF
THE GLOBAL HEALTH EDCTP3 JOINT UNDERTAKING
DECISION N° GB/19/2025**

**AMENDING DECISION N° GB/06/2022 AND APPLYING BY ANALOGY
COMMISSION DECISION C(2025) 2495 (GUIDE TO MISSIONS AND
AUTHORISED TRAVEL)**

THE GOVERNING BOARD OF THE GLOBAL HEALTH EDCTP3 JOINT UNDERTAKING (hereafter "Global Health EDCTP3 JU"),

Having regard to Council Regulation (EU) No 2021/2085 of 19 November 2021 establishing the Joint Undertakings under Horizon Europe, in particular Article 17(2)(v),

Having regard to the Staff Regulations of Officials of the European Union ('Staff Regulations') and the Conditions of Employment of Other Servants of the European Union ('CEOS'), laid down by Council Regulation (EEC, Euratom, ECSC) No 259/68', and in particular Article 110(2) of the Staff Regulations,

Having regard to the Communication C(2014)6543 final of 26 September 2014 from Vice-President Šefčovič to the Commission on the guidelines on the implementation of Article 110(2) of the Staff Regulations with regard to the implementing rules applicable in the agencies, and in particular Point 2.B thereof,

Having regard to the positive opinion of the Staff Committee of the Global Health EDCTP3 Joint Undertaking communicated on 23 May 2025,

WHEREAS

- (1) It is necessary to adopt implementing rules for giving effect to the Staff Regulations;
- (2) The Commission informed the Global Health EDCTP3 Joint Undertaking on 14 May 2025 of the adoption of Commission Decision C(2025) 2495 approving a new guide to missions and authorised travel;
- (3) This notification triggered the nine-month deadline for agencies to decide if they will apply the rules by analogy or request a derogation.
- (4) In application of Article 110(2) of the Staff Regulations, the above-mentioned decision would apply by analogy to Global Health EDCTP3 Joint Undertaking either nine months after the date of its adoption by the Commission or by decision of the Governing Board, at an earlier date;
- (5) The dedicated IT tool for managing missions is configured based on the applicability of Commission Decision C(2025)2495 of 13 May 2025 as of 13 May 2025;

HAS ADOPTED THIS DECISION

Article 1

Point 17 of the annex to Decision GB/06/2022 (reference to Commission decision C(2017) 5323 of 27/09/2017 on Mission guide) is hereby repealed.

Article 2

Commission Decision C(2025) 2495 (approving the new Guide to missions and authorised travel) shall apply by analogy to Global Health EDCTP3 Joint Undertaking.

Article 3

This decision shall enter into force on the day of its adoption and take effect as from 13 May 2025.
