

SUBJECT: EX ANTE PUBLICITY – MEDIUM VALUE CONTRACT – **Audiovisual equipment for “Addis Ababa” meeting room of the Global Health EDCTP3 Joint Undertaking¹**

Description of the contract:

The subject of this negotiated procedure is to enter into an agreement with an economic operator who may provide audiovisual equipment for one of the meeting rooms of the Global Health EDCTP3 Joint Undertaking (hereinafter as referred “Global Health EDCTP3 JU”), located at - White Atrium Building – 2nd floor. Av. de la Toison d'Or 56-60, 1060 Saint-Gilles (Brussels), Belgium.

Price:

The estimated amount is **EUR 100.000,00**.

Description of the contract:

The Global Health EDCTP3 JU “Addis Ababa” meeting room is modular and can operate as one full room or two half rooms (Addis / Ababa). A touchscreen controller must allow simple switching between these modes.

The AV Requirements are:

- Wireless BYOD presentation using ClickShare.
- Easy video conferencing (Teams, Zoom) via ClickShare.
- 4 large LCD displays, wall-mounted cameras.
- Speakers and microphones for full audio coverage.
- Simple user interface: power ON/OFF and room-mode selection.
- Optional: 2 additional wireless lavalier microphones.

About the infrastructure:

- Dedicated rack space with power and network.
- Cable routing through false ceilings.
- All AV equipment connected to dedicated electrical breakers.

Description of the procedure:

This ex-ante publicity is not a call for tender but is the first stage of a negotiated procurement procedure with an estimated amount of EUR 100.000,00 with a minimum of 3 candidates, through which the Global Health EDCTP3 JU may award the above-mentioned contract. The purpose of this notice is to support the Global Health EDCTP3 JU in the selection of the list of candidates to be invited to submit an offer for the contract.

All economic operators interested in providing the services described above should **send a declaration of interest before 23rd of January 2026** by email to procurement@global-health-edctp3.europa.eu with the subject reference *“Audiovisual equipment for Addis Ababa meeting room of the Global Health EDCPT3 Joint Undertaking”*.²

In their declaration of interest interested economic operators should declare their ability to provide the relevant services in compliance with Regulation (EU) 2018/1725 and to take all the necessary measures to prevent any situation of conflict of interest or professional conflicting interest. This information will be assessed in order to select suitable candidates.

All interested economic operators will be informed of the decision of the Global Health EDCTP3 JU. The Invitations to Tender and related documents will be provided by e-mail only to the selected candidates. Please note that the Global Health EDCTP3 JU reserves the right to modify the conditions or to cancel the negotiated procedure. In case of cancellation, all interested economic operators would be informed of this decision. Economic operators who do not express their interest before the deadline and to the address above will not be invited to submit an offer. The latter restriction will not apply to the economic operators directly invited by the Global Health EDCTP3 JU.³

Indicative date for launching the procedure (sending out the invitations): 2nd of February 2026

This notice is in no way binding on Global Health EDCTP3 JU. Global Health EDCTP3 JU contractual obligations commence only upon signature of the contract with the successful candidate. Up to the point of signature, Global Health EDCTP3 JU may cancel the procurement procedure, without the candidates being entitled to claim any compensation.

Data protection

If processing your expression of interest involves the recording and processing of personal data (such as name, address and CV), such data will be processed pursuant to Regulation (EU) 2018/1725 of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data, and repealing Regulation (EC) No 45/2001 and Decision No 1247/2002/EC.
